The Friends of Higgs Beach Board of Directors unanimously recommend that the Parks and Recreation Committee of Monroe County approve the following proposal from the Pickleball organization at Higgs Beach: Until which time the Higgs Beach Master Plan implements the changes related to the tennis and pickleball courts, the County will allow for the two westernmost (Casa Marina Hotel side) tennis courts to be allocated to Pickleball use. The local Pickleball organization, at their cost, will provide for the standards/nets and paint the courts/lines to convert the two tennis courts into six Pickleball courts. Tennis courts would change from using 4 courts on the west to 4 courts on the east.
